**TERMS AND CONDITIONS**

**The following terms and conditions shall apply to all applications for credit facilities with CRUX GLOBAL HOTEL RESERVATION LIMITED (“CRUX GLOBAL”):**

1. Only the authorized persons stated in the Application for Credit Facility may make bookings with CRUX GLOBAL.
2. All products and services supplied by CRUX GLOBAL to the Company (i.e. the Applicant for credit facility) must be paid for within the credit period.
3. Exceeding of the credit limit or credit period is deemed to be an event of default and the entire outstanding sum together with interest accrued thereon is repayable on demand by CRUX GLOBAL.
4. The Company acknowledges that any credit facility granted by CRUX GLOBAL does not apply to “groups and incentive tours” provided by CRUX GLOBAL and all billings and payments for “groups and incentive tours” must be settled by the payment due date as advised by CRUX GLOBAL before departure of such tours.
5. In the case of the Company claims for refunds for cancellation of normal fare air tickets which are paid by credit card, CRUX GLOBAL may recall the discount given to the Company for such air tickets by debiting the credit card for an amount equivalent to the discount paid.
6. The Company shall notify CRUX GLOBAL in writing of any disputed charges. Payment of the non-disputed portion must be made by the due date and cannot be withheld together with disputed portion.
7. Overdue accounts may result in the withdrawal of the credit facilities and all overdue balances carry interest at the rate of 2% per month from the due date.
8. All costs arising out of the collection of overdue payments and/or accrued interest, including but not limited to legal and professional charges, shall be borne by the Company.
9. Any information provided by the Company to CRUX GLOBAL may be supplied by CRUX GLOBAL to any credit rating agencies or service providers and used by CRUX GLOBAL and such credit rating agencies or service providers in connection with the Company's application for credit facilities and/or review of any credit facilities that may be granted by CRUX GLOBAL to the Company.
10. The Company confirms and warrants that all the information provided in this application is true and correct and that no information has been withheld.
11. Any credit facility granted is not transferable.
12. The credit facility is available at the sole discretion of CRUX GLOBAL. Notwithstanding any provisions herein, CRUX GLOBAL may at any time immediately terminate, cancel or suspend the facility or otherwise modify the facility without prior notice to or the consent of the Company or any other party.
13. Notwithstanding any provisions herein, the facility or the outstanding trade balances are repayable on demand by CRUX GLOBAL. CRUX GLOBAL has the overriding right at any time to require immediate payment of and/or security for all or any sums actually or contingently owing to it under the facility.
14. The Company agrees and acknowledges that the terms and conditions herein shall come into effect upon acceptance of the application by CRUX GLOBAL.
15. CRUX GLOBAL may amend change or modify the terms and conditions herein at any time without prior notice to the Company.
16. The terms and conditions herein and credit facilities granted under these terms and conditions shall be governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region.
